Tests all installed or repaired machinery and equipment during dock trials and sea trials. Uses alignment equipment on main shaft and rudder stock lines, stern tube and strut bearing lines. Perform alignment to installed machinery. Possess an understanding of the metric system and ability to convert metric to English and English to metric. Must know proper use of required hand tools and special instruments such as dial indicators and micrometers. Able to rig propeller and tail shaft for removal & installation. As well as experience with blue-fit procedures. Works with minimum supervision. May be assigned miscellaneous tasks outside craft as required. Ability to read, interpret and work from blueprints, job specifications, instruction manuals and manufacturer's handbooks.

- Knowledge of the working properties of the common metals, standard material selection, and the parts and equipment required to perform machining work.
- Provide preliminary sketches or value estimates for materials or services.
- Work on installation, maintenance, repair and of heavy rolling stock (P&H, Grove, and forklifts).
- Communicate with manufacturers if possible, on technical equipment.
- Inspect job site to ensure the safety of employees, customers and vendors from potential hazards.
- Secure job site at the end of shift to minimize risk of loss or theft.
